# ADMINISTRATIVE INSTRUCTION MoJ - No. 12/2023 ON AMENDING AND SUPPLMENTING THE ADMINISTRATIVE INSTRUCTION MoJ-No.01/2022 ON FEES FOR REWARDS AND COMPENSATION OF EXPENSES FOR PRIVATE ENFORCEMENT AGENTS

#### Article 1 Purpose

The purpose of this Administrative Instruction is to amend and supplement the Administrative Instruction MoJ-No.01/2022 on Fees for Rewards and Compensation of Expenses for Private Enforcement Agents (hereinafter: Basic Instruction).

#### **Article 2**

After Article 9 of the Basic Instruction, a new Article with the following text is added:

#### "Article 9A

- 1. Enforcement cases for which the public institution is a creditor are sent to the Chamber of Private Enforcement Agents (hereinafter: Chamber).
- 2. Public institutions, when sending enforcement cases to the Chamber, pay the Chamber a tax in the amount of one (1) Euro for each case submitted for services related to the division of cases.

3. It	f the creditor	, for any	given	reason,	withdraws	the j	proposal	or e	nforcemen	nt case	submi	tted
to tl	ne Chamber,	the tax v	vill not	be retu	ırned.							

4. The institutions from paragraph	2 of this Article will pay	y the tax within	thirty (30) days af	ter
the submission of the case."				

## Article 3 Entry into force

This Administrative Instruction enters into force seven (7) days after publication in the Official Gazette of the Republic of Kosovo.
