INTRODUCTION

The National Strategy on Protection Against Domestic Violence and Violence Against Women 2022 - 2026 was approved by the Government of the Republic of Kosovo in January 2022.¹ This Strategy aims to ensure protection against domestic violence and violence against women in accordance with the standards of international instruments applicable in the Republic of Kosovo. Based on this, the Strategy includes 4 strategic objectives: 1) Prevention and identification of violence, 2) Advancing and harmonizing public policies with international standards, 3) Institutional strengthening in prevention and addressing of domestic violence and 4) Providing general services and specialized support services to victims. These objectives are further divided into 13 specific objectives, each containing at least nine concrete activities.

This is the second Annual Report (January–December 2023) on monitoring the implementation of activities outlined in the Action Plan 2022-2024 for the implementation of the National Strategy on Protection Against Domestic Violence and Violence Against Women 2022 – 2026. The report is prepared based on the reporting standards of strategic documents, according to Administrative Instruction 07/2018 on Planning and Drafting Strategic Documents and Action Plans² and the Manual for Planning, Drafting and Monitoring Strategic Documents and their Action Plans.³ Additionally, the methodology for monitoring the implementation of the Strategy on Protection Against Domestic Violence and Violence Against Women according to the "Monitoring Framework for 2022" was used, which was prepared by the Ministry of Justice in cooperation with the Working Group responsible for monitoring the strategic document.

The report includes data on overall implementation, and implementation according to strategic and specific objectives, and presents overall performance according to implementing structures. The presented data is shown both narratively and graphically to provide more detailed information regarding the implementation of the activities outlined in the Action Plan for the implementation of the Strategy. The Action Plan contains an indicator passport, but the progress assessment according to the indicator passport is done on a triennial basis. Since this reporting is for the annual period January – December 2023, reporting is only done at the level of implementation of the activities outlined for the relevant period. Additionally, besides the charts presented with respect to the outcome of the implementation of strategic and specific objectives for 2023, the outcome from the implementation of the same objectives in the previous reporting period of 2022 are also retained to compare the achieved results year by year. In the end, the report presents conclusions and recommendations, as well as risks and steps that need to be taken to overcome them.

In Annex 1, detailed explanations are provided by the responsible institutions for the implementation of each activity according to the Action Plan for the Strategy.


I. EXECUTIVE SUMMARY

The findings of the Annual Report on the Strategy, which also reflect the current situation regarding domestic violence and violence against women in the Republic of Kosovo, provide information on key activities that are in accordance with the criteria established in local legislation, the Government Program 2021–2025 of the Republic of Kosovo, the Istanbul Convention, the United Nations Convention on the Elimination of All Forms of Discrimination against Women (CEDAW), the Beijing Declaration and Action Platform, the Sustainable Development Goals and the 2030 Agenda, as well as other sectoral strategies. It results that those improvements have been made through the activities implemented under the Strategy in the areas of advancing and harmonizing public policies with international standards, strengthening and enhancing institutional capacities for monitoring and reporting on the implementation of the Strategy, institutional empowerment for the protection and treatment of victims, as well as the treatment of perpetrators of violence against women through the psycho-social program.

These activities of the Strategy are assessed based on three evaluation categories: 1) fullyimplemented; 2) partially implemented or in progress; and 3) not implemented.

Compared to 2022, a noticeable increase in the progress of the implementation of the activities planned for 2023 is observed. Thus, out of a total of 135 activities planned to be carried out during 2023, 86% or 117 activities have been fully implemented or are in progress, while 13% or 18 activities have not been implemented according to the planned dynamics in the Action Plan for 2023.

The activities for this period of the Strategy are assessed based on three assessment categories: 1) fully implemented; 2) partially implemented or in progress; and 3) not implemented.



II. OVERALL IMPLEMENTATION PROGRESS FOR 2023

Regarding the percentage of activities implemented according to the Strategy, Figure 1 shows the status of the implementation of the Strategy activities for the reporting period.

Based on Figure 1, we observe that the majority of the activities foreseen in the Action Plan of the Strategy for this period of 2023 have been fully implemented or are in progress. The data shows that 87% of the activities have been implemented or partially implemented. Out of 135 activities planned during the reporting period, 65 activities (48%) have been fully implemented, 52 activities (39%) have been partially implemented or are in progress, and 18 activities (13%) have not been implemented.


The other activities not included in this report are planned to be implemented according to the Action Plan after 2023.

It is also worth noting that during the reporting period for 2023, in addition to the activities planned for implementation this year, activities that have been continuously linked from the previous reporting period have continued to be implemented. This includes some activities that were not implemented during the previous period but have continued to be implemented this year. As a result, all together, they have reflected a significantly higher level of implementation of activities in this period of the second year of implementation, 2023, of the Strategy (2022-2026).

III. OVERALL STRATEGY IMPLEMENTATION PROGRESS BY STRATEGIC OBJECTIVES

1. Strategic Objective #1: Prevention and identification of violence

Prevention and identification of domestic violence and violence against women have continued to be priorities and addressed as very important phenomena this year according to the Action Plan. Among all the strategic objectives, the highest number of activities is planned within this objective. In this regard, out of a total of 41 planned activities, 20 have been fully implemented (49%), 15 have been partially implemented (37%), and 6 activities remain unimplemented (around 13%). This indicates that the level of implementation in 2023 is significantly higher compared to the previous year (2022).



The significantly higher implementation within this strategic objective is present in the Specific Objective SO 1.4 "Establishment and implementation of programs for the psychosocial treatment of perpetrators of violent crimes." and SO 1.1 "Changing behaviour, attitude, role and stereotype" in relation to the number of planned activities. On the other hand, the highest number of unimplemented activities, compared to the planned activities, is in the Specific Objective SO 1.3 "Promote cooperation between government, media and the private sector for promoting measures for preventing and combating violence".

Key success stories in this objective include: Monthly awareness activities on domestic violence and violence against women with special focus on vulnerable groups of women and girls; Addressing domestic violence and early marriages; Promoting positive role models of Change Agents in the community who challenge gender stereotypes and express zero to violence; Peer education for the prevention and identification of sexual harassment in schools, and for creating critical attitudes towards the negative and sexist portrayal of women and girls in various fields of life; Continuous awareness campaigns by the Kosovo Police on domestic violence, sexual harassment, drug use, human trafficking, traffic safety, and calls to citizens to stop family violence and report cases of violence to the Kosovo Police; Public information sessions through media on the consequences of domestic violence and the responsibilities of the Kosovo Police in dealing with this phenomenon, including information on effective investigation and immediate police response to calls for help,

proper management of dangerous situations, and investigation of all allegations of violence against women and domestic violence, highlighting aggravating circumstances.

A continuing success story during this reporting period is the annual 16 Days of Activism against Gender-Based Violence campaign. Expansion of the home visit program for positive parenting counselling for women and families at health service centres for women and families, or at social work centres, as well as increased identification of domestic violence cases identified through observations during home visits.

Institutionally, the establishment of the Inter-Institutional Group for the Prevention of Early Marriages in the Roma, Ashkali, and Egyptian communities proposed by the Ministry of Justice is noteworthy during this period (2023). The issue of marriages under the age of 18 has also been addressed under the draft Civil Code, and the establishment of this group will help raise societal awareness of the consequences of early marriages and their prevention.

To inform about the measures that need to be taken to address domestic and gender-based violence, intensive informative sessions with civil society have been held, awareness-raising visits for victims regarding the importance of reporting violence, as well as informative sessions in self-help mother associations and groups of women victims of violence in shelters concerning services related to domestic violence through free legal aid and victim compensation.

As part of the home visit program for maternal and child care, pregnant women, mothers, and fathers are advised on positive parenting. Those trained to implement the home visit program are also trained with the module for good parenting. During this year (2023), 252 healthcare professionals, nurses, educators and social workers have been trained to provide these counselling services.

As an initiative to protect children and parents from the harmful use of various internet sites, and to ensure information for children and parents about the safe use of the internet, social media, and electronic communications, a Memorandum of Understanding has been signed between the Independent Media Commission (IMC) and the Terre des hommes Lausanne Foundation in Kosovo (TdHk). According to this memorandum, the parties undertake to enhance the level of mutual cooperation for the implementation of joint activities in the area of child protection in the media. In this regard, the Memorandum aims for IMC licensees to take appropriate measures to ensure the protection of children and minors from programs that may harm their physical, mental and moral development, especially programs with inappropriate content or extreme violence. At the same time, this Memorandum aims to promote media topic addressing child protection, protection against discrimination, community

rights, justice for minors, and similar initiatives, Among the activities envisaged are joint organizations such as: awareness campaigns, training sessions, informative sessions, roundtable discussions, conferences and meetings for the protection of children and minors in audio and audiovisual media services.

A success story during this reporting period is the intensive training of personnel in psycho-social treatment programs for perpetrators of family violence and violence against women. Health personnel from all centres providing psycho-social treatments have been trained, and they have also been certified by the Doctors Chamber for the treatment of perpetrators of violence and health professional training according to their program within the institution where perpetrators of violence are treated by court decision. During this period, all cases prioritized by orders and requests presented by the court and prosecutors at KPFI have been treated, where resocialization and reintegration have also been carried out based on internal protocols and specific programs approved for the treatment of individuals addicted to substances or with mental health problems. Perpetrators of domestic violence, in accordance with their age group, have been treated within institutions by trained professionals to address individuals with substance addiction or mental health issues. Simultaneously, continuous hospital and psychiatric examinations of perpetrators of violence (men and women) have been conducted to provide mandatory psychiatric treatment throughout the year. In this regard, a challenge during this period remains the lack of available spaces for the treatment of perpetrators of violence with mental health and substance addiction problems, resulting in a reduction in the number of cases referred to pre-trial detention due to insufficient bed capacity.

Since the Strategy envisages the preparation and publication of an annual report on the treatment of perpetrators, during the reporting period, for the first time in Kosovo, a program for the treatment of perpetrators of violence against women was launched in 2023, and all preparations have been made for the piloting of the 6-month program in 2024 according to the DULUTH method.

A challenge during this period has been delays in conducting the survey on the general perception of domestic violence and violence against women, which was planned to be completed in 2022 but has not yet been finalized. The statistical report of this analysis has been prepared by the Kosovo Agency of Statistics (KAS), but analysis of the data is lacking. Thus, in December 2023, the Ministry of Justice, in cooperation with the British Embassy, resumed this research, which is expected to be completed by the end of April 2024. Furthermore, a challenge remains in the measurement of the campaign's effectiveness, as no measuring instrument has yet been developed to assess the level of awareness among individuals, especially men and boys, regarding domestic violence and violence against women, which the campaign has targeted.

In addition to the challenges mentioned above, within this objective, difficulties have been identified in the capacities of institutions to implement specific activities in the development of relevant programs and analyses, as well as the lack of sufficient budgetary capacities to organize awareness campaigns, informative sessions and relevant research.

A challenge remains in encouraging the media to establish self-regulatory guidelines and standards to increase respect for the dignity of women, thereby helping to build positive gender roles and prevent violence against women. Educating media professionals to handle issues of domestic violence and violence against women with greater responsibility and professionalism is essential. Preparation and implementation of clear policies and functional complaint mechanisms that prohibit discriminatory materials with sexist content or those that promote domestic violence and the harmful effects of certain traditional or customary practices in both audiovisual and print media are crucial.

Another challenge is encouraging the media to report and analyze domestic violence and violence against women properly, responding professionally and complying with the principles of ethics and personal data protection, in line with the Strategy on Domestic Violence and Violence against Women and the Istanbul Convention. Additionally, cooperation with media and technology information companies to prevent violence, sexual harassment, or persecution of women and girls through social media and the internet remains a challenge.

Progress by results expected within Strategic Objective 1 during the reporting period according to the Strategy

- There has been a noticeable increase in the number of awareness-raising campaigns and informative sessions throughout the reporting period by all key institutional and sectoral stakeholders to raise public awareness not to tolerate domestic violence and violence against women as a result of integrated actions.
- There has been an increase in informative sessions and awareness-raising among civil society, women's associations and shelters dealing with victim protection against violence to encourage reporting of violence cases and inform them of their rights as well as access to free legal aid to address and realize their rights as provided by the applicable legislation.
- Establishment of a database for perpetrators who have received psycho-social services/treatment during and after serving their sentences. This has been realized within the existing database for recording cases of domestic violence and violence against women. This database is a new module developed alongside the development of the program for the treatment of perpetrators of

violence against women. Currently, the treatment program is being implemented, and at the same time, the monitoring process is being developed to enable the measurement of indicators in line with SDG indicators 5.2.2. and 11.7.2, as well as other international-level indicators;

- Curricular programs of pre-university educational institutions have been developed for sexual education at all levels, providing knowledge for the prevention, identification, protection and overall combating of domestic violence and violence against women.
- Training, standards, manuals and protocols have been implemented for the staff
 of pre-university educational institutions to be more professionally prepared to
 identify and refer cases of domestic violence or violence against women
 according to standards;
- In the course of the home visit program for maternal and child care, pregnant women, mothers and fathers are advised on positive parenting. Trainees for the implementation of the home visit program are also trained under the module for good parenting. A total of 42,004 home visits have been conducted, of which 36,336 were for children aged 0-3 years, 5,668 visits were for pregnant women, 1,880 visits were for children in the Roma, Ashkali and Egyptian communities, 511 visits were for pregnant women from the Roma, Ashkali and Egyptian communities, 487 children were referred to other specialists during the visits, 151 children were identified with developmental delays and referred during the home visits, 1,115 social cases were identified and reported, and 9 cases of domestic violence were identified during the home visits.
- Concrete initiatives have been taken to provide psychosocial treatments for perpetrators of domestic violence in accordance with international requirements and standards. The capacity of the Kosovo Probation Service has been strengthened to monitor and rehabilitate perpetrators of violence through intensive training of trainers in the implementation of the Psychosocial Treatment Program for working with perpetrators of domestic violence.

A challenge remains the cooperation between the government, media, and private businesses, which needs to be strengthened and accompanied by positive results in actions against domestic violence and violence against women.


During this reporting period, there has been significant representation of women, men, youth, girls, and boys from all relevant institutions at both local and central levels in all awareness-raising activities organized regarding educating society about domestic violence and violence against women as an intolerable phenomenon. It is expected that

after the research conducted on the general public perception of this phenomenon of violence, the results of the awareness-raising campaigns and their impact on changing behaviours and stereotypes regarding domestic violence and violence against women, in general, will be understood, which is also the aim of Strategic Objective 1 of the Strategy.

2. <u>Strategic Objective #2: Advancing and aligning public policies with international standards.</u>

Strategic Objective 2 includes a total of 30 activities for the reporting period of 2023, aiming to improve the legal framework, invest in human and infrastructural resources, and cooperate closely with civil society organizations to facilitate the processes of victim treatment and management of cases of domestic violence and violence against women.

Within Strategic Objective 2, 22 activities have been fully implemented (73%), 6 activities have been partially implemented (20%), and 2 activities remain unimplemented (6%) during this reporting period.



Specific Objective II.2 "Capacity building for dealing with cases of domestic violence and violence against women" has fully implemented all the activities that are foreseen to be implemented within the reporting period of January-December 2023.

The following are considered success stories related to Objective 2: The comprehensive analysis of the civil and criminal legal framework on violence against women and

domestic violence, along with identifying measures to harmonize this legal framework with international instruments, including CEDAW and the Istanbul Convention. This analysis led to the assessment report on the alignment of laws, policies and measures with the Istanbul Convention by GREVIO. As a result, 3 legislative amendments and supplementations were made, including amendments and supplementation to the Criminal Code, the Criminal Procedure Code and the Law on Protection from Domestic Violence and Violence against Women, all of which have been adopted by the Assembly and are now applicable. Additionally, specific protocols and programs for the treatment of perpetrators struggling with substance addiction or mental health issues were developed and approved. Two Instructions have been drafted and approved for the treatment of perpetrators of domestic violence, outlining how perpetrators are addressed within the three levels of healthcare provision. There has been cooperation with public enterprises to distribute the message "TODAY AND EVERY OTHER DAY" to every household as part of the campaign against violence, along with calls for reporting. Telekom Kosovo VALA has been instrumental in disseminating these messages: "Do not commit violence! Report to 192!" along with the screening of films addressing the phenomenon of violence against women and domestic violence, as well as trafficking and sexual violence against girls, through the Cinematographic Center.

Success stories during this reporting period also include the review of curricula and training modules in the training department of the Kosovo Police and their updating according to the requirements of the national and international legal framework (with a gender perspective included) for enhancing the professional capacities of cadets and police officers; Reviewing short-term training programs that address domestic violence and violence against women as core training in Crime Investigation; Domestic Violence Investigation; Advanced Crime Investigation Training; Police officers' training on defining gender-based violence and sexual harassment according to the laws of Kosovo, as well as on how to handle these cases, in accordance with the Kosovo Criminal Code; 12 types of training session in total, including 19 training sessions covering topics of sexual harassment and gender-based violence, among others, have been conducted, including specialized trainings such as: Sexual Harassment in the Workplace; Approach to Gender-Based Violence Training; and Domestic Violence Investigation Training;

Furthermore, a success story is a progress in the preparation and implementation of the curriculum and the conduct of training for healthcare workers to identify, treat and refer cases of domestic violence and violence against women.

Progress has also been made in the allocation of physical space and friendly rooms for interviewing victims and perpetrators of violence, while efforts continue to expand these facilities to other police stations. At the same time, an increase in the number of Protection Orders issued by the court to protect victims from perpetrators of violence has been observed.

Progress by results expected within the Strategic Objective 2 during the reporting period according to the Strategy:

Some of the expected results from the implementation of specific objectives under Strategic Objective II during the reporting period are:


- Increase in the number of legislative acts and policies approved for protection against domestic violence and violence against women.
- The considerable number of professionals trained and educated by all responsible institutions for the treatment of cases of domestic violence and violence against women according to protocols and standards derived from the legal acts foreseen in the Strategy. High participation of institutional representatives and professionals from both genders observed.
- Development and advancement of an integrated inter-sectoral database for the collection and processing of data related to cases of domestic violence and violence against women.

During the reporting period, there is an increase in responsibility and higher prioritization at the institutional level in the investigation of reported cases of all forms of domestic violence and violence against women and in the punishment of perpetrators of violence in accordance with the applicable legislation. In parallel, concrete initiatives have been launched for the development and implementation of pilot programs for the rehabilitation of perpetrators of violence, which are also expected to impact the reduction in the number of criminal charges against adult and juvenile perpetrators in the future, which is also the aim of Strategic Objective 2.

3. <u>Strategic Objective #3: Institutional strengthening in the prevention and addressing of domestic violence</u>

34 activities have been planned within Objective 3. Among these activities, 18 have been fully implemented (53%), 13 have been partially implemented or are in progress (38%), and 3 remain unimplemented (8.8%).

Strategic Objective 3 foresees 5 specific objectives, within which the greatest progress is reflected in Specific Objective III.5 "Improving access to justice for victims/survivors of violence", while the lowest percentage of implementation is presented in Specific Objective III.4 "Research, collection and updating of inter-institutional data for case identification".

The success stories during this reporting period within this objective are: almost double increase in the number of information sessions held with various groups of women, young women, girls, men, young men, and boys, about gender roles and the existence of coordinating mechanisms for protection from domestic violence and violence against women at the local level, as well as protection, treatment and access to justice through these mechanisms, compared to the previous reporting period; Furthermore, in all municipalities, the '16 Days of Activism' campaign was conducted, and efforts were made to raise citizens' awareness about prevention of domestic violence and violence against women and the consequences of domestic violence, with information sessions in schools, meetings, visits, etc.

Additionally, the implementation of activities with youth continued in the "Municipality for Youth" project in municipalities with vulnerable communities. The first round of the training and subgrant program for youth was implemented in 10 municipalities across Kosovo, which are beneficiaries of the project with agreements signed by the MLGA for implementation. There was a significant increase in the

participation of girls in the implementation and monitoring of subgrants in these municipalities compared to boys, including all vulnerable groups.

Another success story during this period is the drafting of the document "Manual 2023", which lists information about violence and its forms, as well as the services provided by responsible institutions, including free legal aid and crime victim compensation. Information leaflets on the forms of violence, responsible serviceproviding institutions, and reporting numbers have also been prepared and distributed. Additionally, leaflets have been prepared on new forms of violence provided for in the Criminal Code - Sexual Harassment. To continuously raise citizen awareness, information meetings have been held with various municipal stakeholders (from Free Legal Aid providers). The content, design, publication and distribution of materials to inform victims/survivors of domestic violence and violence against women as well as the general public of their rights and the services where they can get help, including free legal aid for those exposed to violence, have been prepared in a language they understand to ensure accurate information about services for domestic violence cases. Information has also been prepared and distributed in official languages and formats suitable for persons with special needs (braille alphabet, etc.) about the applicable legislation, the protection offered, and the relevant institutions where victims/survivors of domestic violence and violence against women should address their cases.

During the reporting period, financial support has been provided for Shelters providing Housing Services to victims of Domestic Violence: To ensure financial sustainability for shelters that provide housing services for victims of domestic violence, the Ministry of Justice has increased the budget for Shelters from €1 million to €1.5 million. From this budget, 10 shelters across Kosovo are, for the first time, fully supported for the housing and psycho-social treatment services of victims during their accommodation in the shelters.

A success story is also the establishment of the monitoring and evaluation system for the implementation of the National Strategy on Protection against Domestic Violence and Violence against Women 2022-2026 during this reporting period. The reporting instrument was finalized after consultation with responsible institutions reporting on the implementation of the National Strategy on Protection against Domestic Violence and Violence against Women (2022-2026). This instrument provides a clear overview of the implementation of the Strategy and helps the Ministry of Justice in its monitoring and evidence-based decision-making. For the first time, this format enables the reporting of non-governmental and international organizations in support of the implementation of the Action Plan activities.

Challenge: Regarding the challenges related to the specifics of this objective, there are several actions that remain to be implemented, which are related to limited human capacities and the determination of the type and methodology in collecting and analyzing these data, in accordance with the definitions and requirements of the Istanbul Convention. These issues are expected to be addressed with a Guide on Inter-Institutional Cooperation, which also includes strengthening the capacities of the responsible central and local institutions for collecting administrative data in accordance with the agreed methodology.

Although cooperation with civil society has been evident with support from central and local state bodies during this reporting period, this cooperation needs to be further intensified in the future and extended to all municipalities.

At the same time, during this reporting period, challenges and difficulties have been observed in proper budget planning by the relevant institutions where victims are addressed. These institutions face difficulties in carrying out activities for the protection of victims/survivors of domestic violence and violence against women.

Progress towards the expected results from the implementation of specific objectives under Strategic Objective III during the reporting period:

- The Government of Kosovo has dedicated the appropriate budget and adequate funds to strengthen the Office of the National Coordinator against Domestic Violence, to enable efficient coordination and monitoring of actions against violence. It remains for the office to be further strengthened with sufficient human resources for more efficient functioning.
- A Guide for the standards of operation and action of coordinating mechanisms at the local level against domestic violence and gender-based violence has been drafted and launched, in accordance with the multi-sectoral coordinated approach according to the new applicable law. The purpose of the Guide is the establishment and coordination of the local coordinating mechanism, the drafting of procedures and protocols including the local level database, advocacy for budget allocation from municipal decision-making, mapping and defining referrals for specific services, as well as capacity building. Also, coordination and alignment of policies with women's organizations and civil society by supporting women in the community and marginalized groups.
- Progress has been made in the establishment and operationalization of local Coordinating Mechanisms for the management of cases of domestic violence and violence against women in several municipalities, but there is still a need to work on establishing and operationalizing these mechanisms in other municipalities of Kosovo. Some municipalities have been supported in breaking

down this national strategy into local strategies, including the drafting of work plans. Furthermore, it remains to work on ensuring adequate human and financial resources to ensure the smooth functioning and sustainability of these mechanisms in all municipalities of Kosovo.

• The Kosovo Police has been strengthened through the establishment of a special directorate at the central level and units at the regional and local levels for handling cases of domestic violence and violence against women. Simultaneously, logistical support has been provided for units handling cases of domestic violence by ensuring transportation for victims to access emergency services, whether medical, court appearances or other support services.

A challenge remains in securing emergency funds (petty cash) for the Kosovo Police and Centers for Social Work (CSW) to meet the emergency needs of victims during the handling of domestic violence cases while staying at police stations and CSWs.

Regarding data for the management and coordination of cases and administrative data for cases handled in a multi-sectoral manner, an Administrative Instruction is expected to be drafted related to detailed guidelines, protocols and the methodology of collecting and updating information from all responsible institutions in real-time for cases that seek and receive free legal aid and professional support. This Guide will contribute to improving the way data is collected by also focusing on indicators related to sustainable development. In this regard, it is expected that the victim reporting categories (girls, women, boys and men) for sexual violence, not just domestic violence, will be recorded in the database, according to categories up to 15 years old and those over 18 years old, in accordance with SDG 16.2.3 definitions and requirements of the Istanbul Convention. Furthermore, this Guide will strengthen the capacities of responsible central and local institutions for collecting administrative data in accordance with the agreed methodology.

During the implementation period in 2023, significant efforts and activities have been made to improve access to justice for all women and girls, and the number of applicants for legal aid is increasing. The issue of ensuring the sustainable provision of free legal aid throughout Kosovo remains a challenge due to insufficient human and financial resources, which are occasionally covered by donors for areas not covered by existing regional offices in Kosovo.

Within Strategic Objective III, progress has been made in the operationalization of coordinating mechanisms in several municipalities during the reporting period, and it

is expected to advance similarly in other municipalities. In parallel, coordination has also been improved, both among these mechanisms and with civil society as a whole, and this will continue in future implementation periods of the Strategy.

Meanwhile, with the approval of the Law on Protection from Domestic Violence, the responsibility of the National Coordinator's Office as a state body overseeing coordination, monitoring the implementation of the Istanbul Convention, and reporting on the implementation of this Convention to GREVIO has been defined. According to the new Law on Protection from Domestic Violence, Violence against Women and Gender-Based Violence, the duties and responsibilities of the National Coordinator have been specified. Similarly, according to the applicable law, political responsibility in addressing domestic violence and violence against women has increased. Therefore, in the coming period, further work will be done to advance the monitoring and evaluation processes of institutions, both for the implementation of this national strategy and for public policies against violence in general.

During the reporting period, delays have been noted in conducting periodic national surveys (every 4 years) on the phenomenon, scale, profile of perpetrators and the perception of citizens regarding domestic violence and violence against women, which remains to be carried out next year. Furthermore, in the future, efforts will continue to be made to create facilities for employers/businesses employing sensitive categories of society, including victims of domestic violence and violence against women, which is related to the process of the measure mentioned above.


Regarding the implementation process, a database for the number of reintegrated and empowered victims/survivors of violence through relevant programs, at both central and local levels, has been created, starting at the end of the reporting period (2023). Various institutional mechanisms have been involved in implementing this measure for a six-month period, with the possibility of continuation in future reporting periods.

4. <u>Strategic Objective #4: Provision of general services and specialized support</u> services to victims

Strategic Objective IV contains 28 activities outlined in the Action Plan. During the reporting period, 7 activities have been fully implemented (25%), 14 activities are in progress (49%), and 7 activities remain unimplemented (25%).

Unlike previous strategic objectives, where the majority of activities have been implemented or are in progress, in this section, there is a noticeably lower implementation of planned activities by relevant institutions.

Figure 6 presents the results of the applicability of specific objectives for 2023 and those of 2022, showing that this year's applicability is at a higher level than the previous year, but there are still delays in implementation compared to other strategic objectives during the reporting period.



Out of the two specific objectives outlined, Specific Objective IV.1, "Support and strengthening of specialized services for victims/survivors from all groups and child victims and witnesses of violence" shows better applicability compared to other activities of this Strategic Objective IV. For this specific objective, 55% of the activities have been fully implemented or are in progress (IV.1), whereas, for specific objective IV.2, only 13% of the planned activities within Strategic Objective IV are in progress.

However, some of the activities have been successfully implemented during the reporting period for 2023, including the appointment of coordinators and specialized judges in courts for handling cases of domestic violence in civil and criminal aspects; Profiling of professionals providing reintegration services for sustainable empowerment of victims; 67 officers profiled in 33 municipalities; Establishment of a Unit for handling cases of domestic violence within the Prosecution Offices where a large number of domestic violence cases are presented. In all basic Prosecution Offices, Coordinators and Deputy Coordinators for domestic violence have been appointed, and

there has been an increase in the number of female Police Officers from 995 to 1024 compared to the previous reporting period.

Challenges, within this objective, still arise during this reporting period concerning serious challenges regarding planning and engagement in implementing actions (providing supportive and shelter services for specific groups such as boys and men victims of domestic violence, LGBTI+ individuals, etc.); lack of cooperation with the public and private sectors (providing employment opportunities for survivors of domestic violence and violence against women); and inadequate budget planning (financial support for services for child victims and child witnesses of violence as well as victims of sexual assaults provided by public institutions or specialized NGOs).

Challenges (delays) have also been observed in recruiting NGOs to provide public financial support for funding projects that contribute to the economic empowerment and well-being of victims of domestic violence/violence against women in implementing the priorities set out in the Strategic Objectives of the National Strategy on Protection against Domestic Violence and Violence against Women 2022-2026 and its Action Plan for this objective. Although the call has been announced three times by the AGE, according to the evaluation of the selection committee, none of the NGOs has met the criteria based on the public call.

The shelters (10) serving to handle cases of domestic violence and violence against women continue to provide quick access to available services for victims and serve as a platform for advocacy to obtain financial resources from the respective municipalities and support the inclusion of gender-based violence survivors in social housing programs. However, so far, only 21 municipalities provide financial support to these shelters, and it remains a challenge to involve other municipalities in their financial contribution to support victims of violence.

A continued challenge is also subsidizing kindergarten payments to victims of domestic violence and violence against women: There is still no accurate data on the number of beneficiary children. Until the reporting period, only 11 municipalities subsidize payments for kindergartens.

Delays in the development of a three-year social housing plan in the municipalities and planning of social housing for victims of cases of domestic violence and violence against women (rents, provision of housing). 15 municipalities have approved the three-year plan, 8 municipalities are in progress, while other municipalities do not have a social housing plan

Progress and challenges towards the expected results of implementing specific objectives under Strategic Objective 4

 Adequate funds have been allocated to NGOs to provide specialized support services for survivors of violence, in accordance with the

- requirements/standards of the Istanbul Convention; however, there is a delay in selecting some NGOs that will assist victims in their sustainable reintegration due to their failure to meet the selection criteria by the reporting period
- Lack of concrete plans and programs to invest with priority in the reintegration and sustainable empowerment of violence survivors through the efficient functioning of relevant programs;
- There is still no evident progress regarding the improvement of women's property rights, as another opportunity for their long-term empowerment or enjoyment and assurance of equal exercise.

Slower implementation is observed in the operationalization of specialized support service centres for all forms of violence and challenges in obtaining the necessary budget support from central and local government. Similarly, challenges and delays are observed in supporting and operationalizing reintegration programs, which enable the sustainable empowerment of survivors of various forms of violence.

IV. OVERALL PERFORMANCE BY IMPLEMENTING STRUCTURES

Regarding the performance of responsible institutions, the implementation status of activities during the reporting period is reflected in Table 1.

V. CONCLUSIONS AND RECOMMENDATIONS

The National Strategy on Protection against Domestic Violence and Violence against Women 2022 – 2026 has shown significantly better implementation during the second year compared to the first one, with around 87% of the activities specified for the reporting period being fully implemented or in progress. Out of a total of 135 activities, 18 activities (13%) were not implemented.

Progress achieved in the implementation of strategic objectives during this reporting period includes:

- Improvement of the legal framework and strengthening of capacities for handling cases of domestic violence and violence against women, considering the standards of the Istanbul Convention;
- Establishment of the Directorate within the Kosovo Police for the Prevention and Investigation of Domestic Violence;
- Amendment/supplementation of the Law on Protection from Domestic Violence and harmonization with the Istanbul Convention;
- Development of guidelines/protocols for the functioning and operation standards for coordinating mechanisms at the local level, in line with the coordinated multi-sector approach;
- Promotion of positive models of "Change Agents in the Community", challenging gender stereotypes and expressing intolerance towards violence through promotional videos featuring different actors aimed at community change;
- Full analysis of the civil and criminal legal framework on violence against women, and domestic violence, as well as the identification of measures to be taken to align this legal framework with international instruments, including CEDAW and the Istanbul Convention;
- Creation of new modules in the integrated database to identify cases of domestic violence and address perpetrators of violence against women;
- Certification of 15 facilitators to provide the program for treating perpetrators of domestic violence;
- Strengthening the capacities of Kosovo Probation Service, Correctional Service, Social Workers, and Clinical Psychologists to provide the program for treating perpetrators of violence against women;
- Enhancement of the monitoring and evaluation system for the implementation of the National Strategy on Protection against Domestic Violence and Violence against Women 2022-2026.
- Strengthening the capacities of officers of responsible institutions integrated in the database against domestic violence, in identifying cases in the application during the recording process;

- Preparation and distribution of information in official languages suitable for persons with special needs (braille, etc.), on the applicable legislation, the protection offered and the relevant institutions where victims/survivors of domestic violence and domestic violence should be addressed towards women;
- Greater involvement of civil society and strategic partners in the implementation of Strategy activities;
- The increase in the budget for shelters, from €1 million to €1.5 million. From this budget, 10 shelters at the Kosovo level, for the first time, are fully supported for shelter and psychosocial treatment services for victims during their sustainability in shelters.
- Training on domestic violence and standard procedures for 150 police officers from the investigation sector and police officers from patrol units as first responders in domestic violence cases;
- 2638 cases of domestic violence have been investigated;
- Increasing the number of female police officers from 995 to 1024;
- The increase in information sessions from 28 to 51 sessions within the year in primary and secondary schools organized by municipalities with different groups of women, young women, girls, men, young men and boys about gender roles and the existence of coordinating mechanisms for protection from domestic violence and violence against women at the local level, as well as protection, treatment and access to justice through these mechanisms;
- Two guidelines have been prepared for the treatment of perpetrators of violence and the training of health professionals according to their program within the institution where perpetrators of violence are treated by court decision;
- Education of peers, girls, and boys (peer education) for the prevention and identification of sexual harassment in schools, as well as for maintaining a critical stance towards the negative and sexist portrayal of women and girls in various areas of life;
- Appointment of coordinators and judges profiled in courts for the treatment of domestic violence cases in civil and criminal aspects;
- Establishment of a unit for the treatment of domestic violence cases in Prosecution Offices where a large number of domestic violence cases are presented;
- Joint training on the treatment and prevention of domestic violence and violence against women for police officers, prosecutors and judges on duty, Victim Advocates, CSW, MoJ, VAO, Forensic Psychiatry, in criminal and civil aspects and the impact of trauma on the victim;
- A total of 42,004 home visits have been conducted for children aged 0-3 years, during which, among other things, 1115 social cases and several (9) cases of domestic violence have been identified and reported;

- The Guideline for Processing Cases for Free Legal Aid has been implemented, prioritizing cases of victims of violence and marginalized groups, and addressing civil, family and property legal issues.
- Free legal aid has been provided to 6081 citizens, 2890 women and 3191 men, including victims of domestic violence during 2023 in criminal and civil matters. In civil family field, free legal aid has been provided to 782 beneficiaries of free legal aid.
- By gender, 527 women and 255 men from all marginalized groups and ethnicities have benefited. A total of 1214 legal actions have been taken thereof.

VI. RISKS AND STEPS TO ADDRESS THEM

Based on the current state of implementation of the Strategy, some of the identified risks are:

- The full operationalization of the Office of the National Coordinator against Domestic Violence with the necessary human capacities and resources for monitoring the implementation of the Strategy on Domestic Violence and Violence against Women;
- Inadequate planning of activities and lack of sufficient budget for financing activities arising from the Strategy;
- Lack of an emergency fund for the needs of victims during the period when they seek help from the police;
- Failure to clarify roles and competencies of some institutions for the implementation and reporting of activities arising from the Strategy according to the Istanbul Convention;
- Lack of accountability from some responsible institutions and institutional
 officials, improper addressing of activities, and inadequate reporting against the
 set indicators/measurable indicators specified in the Strategy and according to
 international standards for victims of violence (according to the Istanbul
 Convention);
- Limited institutional capacities to improve the collection and reporting of data and the real-time use of the database created at the Ministry of Justice with the coordination of all relevant institutions;
- Lack of data showing the results and impact of awareness campaigns carried out among men, boys and the general public against changing perceptions and stereotypes about gender-based and sexual violence.
- Lack of proper cooperation between the Government, media, civil society and private businesses regarding actions against domestic violence and violence against women.
- Insufficient support programs for the economic reintegration of violence victims and the provision of housing for single mothers who are victims of violence, as well as the lack of financial support for their children in kindergartens, etc.

To address these risks, the implementing institutions of this Strategy must undertake the necessary actions as soon as possible, always ensuring close coordination with all stakeholders.

Regarding these actions, steps should be taken to:

- Review the Action Plan and more clearly define the roles and obligations of the responsible institutions for the implementation of the Strategy on Domestic Violence and Violence against Women (2022-2026);

- Preliminarily and timely plan the budget planning, allocation of adequate funds and creation of budget lines for the proper and timely implementation of activities according to the dynamics of the Action Plan of the Strategy;
- Build capacities for data collection and reporting related to domestic violence and violence against women, as well as actions taken or delays in taking these actions;
- Ensure more structured and accurate reporting of data by relevant institutions regarding victims of violence according to the indicators defined in the Strategy (Istanbul Convention) and international standards;
- Strengthen and further empower the level of monitoring of the implementation of activities by responsible institutions for the implementation of the Strategy, and ensure accountability and transparency in reporting cases of domestic violence and violence against women, including the protective measures and services that have been taken or not taken for them;
- In future reports, institutions should focus more on reporting their activities (results) with a primary focus on victims of violence and women and girls who seek help and support from relevant institutions in cases of threats and for preventing violence against them, as well as those who seek support in realizing their rights, not only in initiating procedures but also until the final realization of their rights in protection against violence;
- Proper cooperation with strategic partners, civil society, media and private businesses concerning the actions envisaged according to the Strategy and the Istanbul Convention.

During the reporting period, it has been observed that the roles, competencies and obligations of some institutions responsible for implementing the Strategy have undergone changes from those initially envisaged in the Strategy, resulting in some activities remaining unimplemented so far. Therefore, it is necessary to review the Strategy document and the Action Plan and to more precisely define the roles and obligations of some relevant institutions that will be responsible for implementing the envisaged activities in the next reporting period and beyond.

The AFLA has not fully complied with Article 22 of the Law on Free Legal Aid, which foresees the opening of Mobile Offices in all municipalities of Kosovo to achieve full coverage in the entire territory of the Republic of Kosovo. The AFLA's budget request to open Mobile Offices in 6 municipalities has met with support from the Ministry of Justice. With the last budget circular of 2024, 4 (four) legal official positions were provided for the mobile offices supported by GIZ, and 1 (one) legal official position was also allowed for the opening of the mobile office in another municipality. But free legal aid should be offered in all municipalities of the Republic of Kosovo because the nonopening of these offices represents unequal access to justice for all citizens of these municipalities, who are in a weak economic situation. As for the municipality of Gjilan, during 2022 it has subsidized the children of self-supporting mothers and is in the process of subsidizing kindergarten

		payments for children of victims of domestic violence. While the municipality of Lipjan implements the subsidy of kindergarten payments for children of domestic violence from 2016-2017.
		In the performance report, the achievements for each municipality in this field are reflected.
