## ON AMENDING AND SUPPLEMENTING LAW NO. 05/L-049 ON ADMINISTRATION OF SEQUESTRATED AND CONFISCATED PROPERTY

## LAW ON AMENDING AND SUPPLEMENTING LAW NO. 05/L-049 ON ADMINISTRATION OF SEQUESTRATED AND CONFISCATED PROPERTY

### Article 1 Purpose

The purpose of this law is to amend and supplement Law no. 05/L-049 on Administration of Sequestrated and Confiscated Property (OG/No. 12/14 April 2016, Prishtina).

#### Article 2

Article 4 paragraph 1., sub-paragraph 1.10. of the Basic Law, after the word "enables" the following sentence is added: "renting or".

#### Article 3

Article 18 of the Basic Law, after paragraph 3., a new paragraph 3a, is added with the following text:

3a. The Agency can rent out the sequestrated immovable property according to the court decision.

#### Article 4

Article 19 paragraph 4. of the Basic Law is reworded as follows:

4. The Agency may sell the items, rent them out or hand them over for use to the Government.

#### **Article 5**

Article 26 paragraph 2. of the Basic Law is amended and supplemented so that after the word "sequestrated", the sentence "and income accruing from rent" is added.

### Article 6

The title of Chapter VII of the Basic Law is supplemented and amended as follows:

## CHAPTER VII SALE AND LEASE OF SEQUESTRATED AND CONFISCATED PROPERTY

LAW NO. 08/L-034 ON AMENDING AND SUPPLEMENTING LAW NO. 05/L-049 ON ADMINISTRATION OF SEQUESTRATED AND CONFISCATED PROPERTY

#### Article 7

The title of Article 27 is supplemented and amended as follows:

# Article 27 Sale and lease of property

#### Article 8

- 1. Article 27 paragraph 3. of the Basic Law is amended and supplemented so that after the word "sale", the sentence "and rent" is added.
- 2. Article 27 paragraph 4. of the Basic Law is amended and supplemented so that after the word "sale", the sentence "and rent" is added.
- 3. Article 27 paragraph 8. of the Basic Law is reworded as follows:
- 8. The manner and procedure of sale and lease of sequestrated and confiscated movable and immovable property is governed by a sub-legal act adopted by the Government, with the proposal of the Minister of Justice, which shall be issued within six (6) months from the entry into force of this law.

# Article 9 Entry into Force

This Law shall enter into force fifteen (15) days after its publication in the Official Gazette of the Republic of Kosovo.
