## I. EXECUTIVE SUMMARY

This report presents the progress in the implementation of the Action Plan of Transitional Justice Strategy for the period January–December 2025.

During 2025, out of a total of 88 planned activities:

- 23 activities have been fully implemented (26%);
- 30 activities have been partially implemented or are in progress (34%);
- 35 activities have not been implemented (40%).

These data show that the implementation of the Strategy has achieved a moderate level of progress, facing significant challenges to completely implement activities that were planned.

The main challenges that were identified include:

- budgetary limitations;
- lack of inter-institutional coordination;
- limited human and professional capacities;
- change of institutional priorities;
- lack of activity integration in the legislative and strategic plans.

The report recommends concrete measures to improve implementation, including strengthening coordination, increasing capacities and ensuring sustainable financial resources.

## II. GENERAL INFORMATION

The Transitional Justice Strategy (2024-2034) and its Action Plan (2024-2026/7) <sup>1</sup>were approved by the Government of the Republic of Kosovo in June 2024.

The rule of law is one of the main principles of the constitutional order of the Republic of Kosovo. In this regard, the Government of the Republic of Kosovo has specifically, in the Program of the Government of the Republic of Kosovo 2021-2025 and the Annual Work Plan of the Government, as well as in the Program for the Rule of Law, defined its commitment to the drafting of the Transitional Justice Strategy. Through a comprehensive approach, the Government, respectively the Ministry of Justice, has been committed to identifying and

promoting various processes guaranteeing the war crimes victims the right to justice and truth, including development of a reparative platform, which will aim to calculate the human and material damages caused during the war<sup>2</sup>. The comprehensive approach is in full compliance with the constitutional principles of the Republic of Kosovo, the EU integration process and international standards. It is also a continuation of the commitment of institutions to address massive human rights violations, address war crimes, crimes against humanity, the crime of genocide and violations of values protected by international law, as well as provide justice to victims and survivors.

Since the end of the War in 1999, confronting the past and traditional justice in Kosovo in general lacked a strategic vision, inclusion of victims and institutional sustainability. For the lack of a comprehensive vision and strategy, for more than two decades, international and local authorities, as well as civil society, have engaged in fragmented and individual transitional justice initiatives. The lack of institutional coordination, as well as the lack of continuity and sustainability of government policies, has contributed to the lack of progress in seeking and recognizing the truth, justice, and institutional reform. It was for this reason and to create a sustainable platform that the Government of the Republic of Kosovo, namely the Ministry of Justice, has drafted this strategic document. The purpose of this document is to create a comprehensive framework for addressing massive human rights violations and war crimes, respectively, to build the foundations of a peaceful future. The purpose of the Transitional Justice Strategy is to help correct injustices and heal the traumas caused by the painful past. Through the development of a comprehensive national strategy for transitional justice, it becomes possible to create a sustainable platform to establish facts about the past, ensuring reparation for injustices and traumas related to the war, protecting individual and collective memory, reforming and gaining trust in institutions. Furthermore, the direct goals of the Transitional Justice Strategy are to end impunity and bring dignity back to victims. In doing so, the long-term goals are focused on preventing conflicts and human rights violations, restoring civic trust, reconciliation, the rule of law and democratic order.

This Strategy has been developed based on the Constitution of the Republic of Kosovo<sup>3</sup>, international human rights standards and the principles of transitional justice. Consequently,

the strategy is based on the four pillars of transitional justice, namely **truth-finding, justice, reparations and institutional reform**, being also state obligations in the Republic of Kosovo.

The Constitution of the Republic of Kosovo guarantees international human rights standards; it provides a central role in international human rights agreements, also guarantees enhanced protection for the rights of minority communities. These constitutional values provide the legal basis for social and political transformation, in a legal state, inclusive and integrated society, guaranteeing, among other things, that social and political processes function and overcome the legacy of discrimination, lack of respect for human dignity from previous repressive systems and regimes.

The international legal basis or the international law on which the drafting of strategy is based includes:

- The Charter of the United Nations;
- The Universal Declaration of Human Rights;
- International conventions on human rights;
- International humanitarian law;
- International Criminal Law and
- International Refugee Law
- *“Updated Principles for the Protection and Promotion of Human Rights through Action to Combat Impunity”*
- *“Basic Principles and Guidelines on the Right to Reparation and Compensation for Victims of Gross Violations of International Human Rights Law and Serious Violations of International Humanitarian Law”*;
- *“European Union Policy Framework in Support of Transitional Justice”*

## **Vision of Strategy**

Kosovo's vision for transitional justice is to create a strategic platform aiming to ensure the right of victims and the right of society for truth, reparation, justice and guarantees of non-repetition is realized.

## **Aims of Strategy**

The goals of the Strategy include: addressing crimes of serious violations of human rights, international humanitarian law and other crimes comprising violation of international law

## **Time Period Covered**

The Transitional Justice Strategy addresses the period between 1989 and 2000, starting from 1989, the year of the abolition of Kosovo's legal and political autonomy and the beginning of the destruction of the constitutional order of the former SFRY, the period of the war 1998-1999 until 2000, based on the following principles and values:

- Victim-centered approach;
- Comprehensive approach;
- Gender sensitivity;
- Compliance with international norms and standards;
- Integrity and impartiality;
- Participation and empowerment;
- Equality and non-discrimination;
- The principle of "do no harm".

Based on the above values, the strategy aims to:

- Enable to establish a social dialogue about the past through restorative justice;
- Provide necessary conditions for achieving justice for all victims;
- Ensure the implementation of a comprehensive, transparent process of material, symbolic and psychosocial support for all victims;
- Ensure that all strategic objectives respect gender sensitivity and that each program includes measures to explore gendered experiences and to redress gender-based violations.

### **Strategy Action Plan**

To realize and implement the strategy an action plan with four strategic objectives (based on the four principles mentioned) has been drafted including: 17 specific objectives and 114 activities. The strategy covers 10 years while action plan 3 years only and will be reviewed every three years. The Action Plan covers the period from June 2024 to June 2027. According to the action plan, the activities are spread over three years, of which some are only for one year and some should get started in the first year and continue without interruption in the other years. According to the division in years, the activities are planned to start or develop as follows:

- **2024 71 Activities**
- **2025 88 Activities**
- **2026 69 Activities**

## **Data Collection Process**

Based on Article 22, paragraph 2 of the Regulation (GRK) No. 17/2024 on the Work of the Government of the Republic of Kosovo, the Ministry of Justice, as the responsible ministry, is responsible for the continuous monitoring of the implementation of the approved strategic document. It was based on the above article that the Inter-Ministerial Group for Monitoring and Implementation of the Transitional Justice Strategy was appointed by Decision No. 349/2024, dated 27.09. 2024.

Data collection for the preparation of report was carried out through an informal plan prepared by the Transitional Justice Division, approved by the Inter-Ministerial Group. During 2024, the Inter-Ministerial Group met two times and no meetings during 2025. At these meetings, the monitoring and reporting process for implementation was agreed upon.

Through this process responsible contact officers have been appointed in each ministry and public institution and they are supposed to communicate with the Transitional Justice Division in the MoJ, to collect relevant data and report on the implementation of the Action Plan according to the responsibilities of the respective institutions.

To facilitate the reporting process, the Transitional Justice Division has prepared a work plan that includes:

- Distributing of activities of the Action Plan Strategy according to the responsibilities of each institution and sending them for implementation;
- Preparing ten guidance documents for the institutions of the three branches of government;
- Developing and distributing of an electronic Excel form for reporting;
- Organizing roundtables/workshops with contact officers to present the reporting format, the method of completion and agreeing on reporting deadlines;
- Creating an information field with institutions, through which face-to-face meetings with the heads of institutions, as well as workshops/thematic round tables have been held;
- Drafting special documents for specific aspects of the implementation of the Strategy, especially in the field of capacity building.

The Annual Report for the period from January to December 2025 has been drafted in accordance with Article 22, paragraph 3 of Regulation (GRK) No. 17/2024, which presents achievements against objectives, the timelines of activities and the actions taken.

## **Achievements against objectives through established indicators and timeline of actions taken**

Activities for this period have been assessed based on four assessment categories: 1) planned activities; 2) completely implemented activities; 3) activities partially implemented or in progress; and 4) activities not implemented.

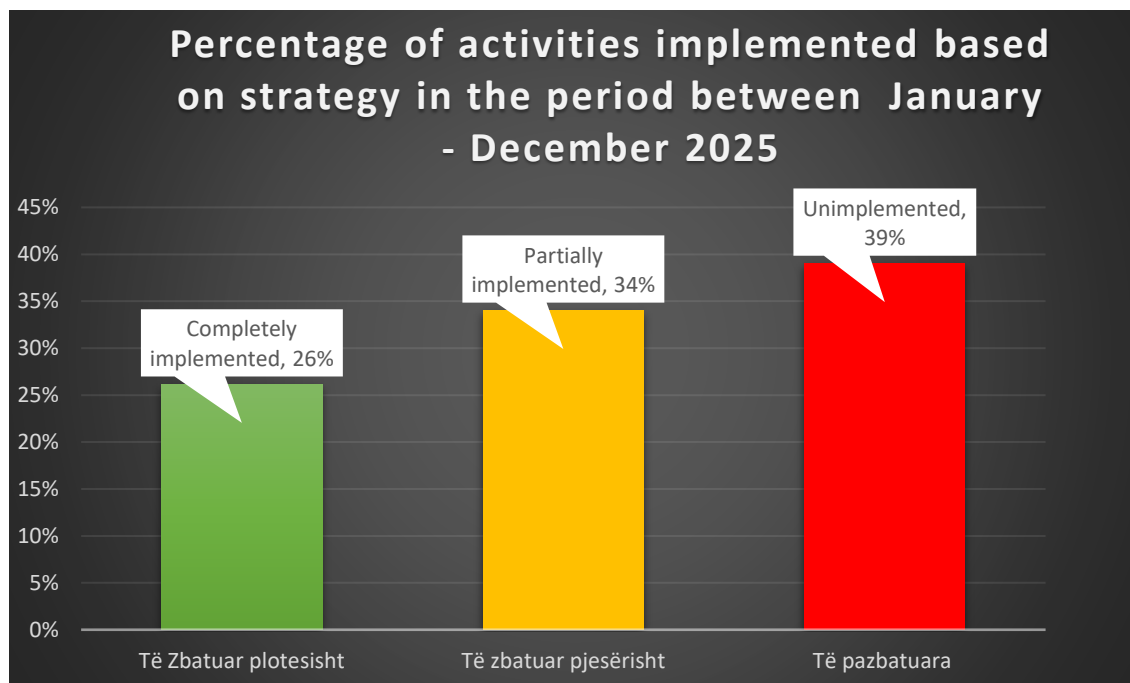

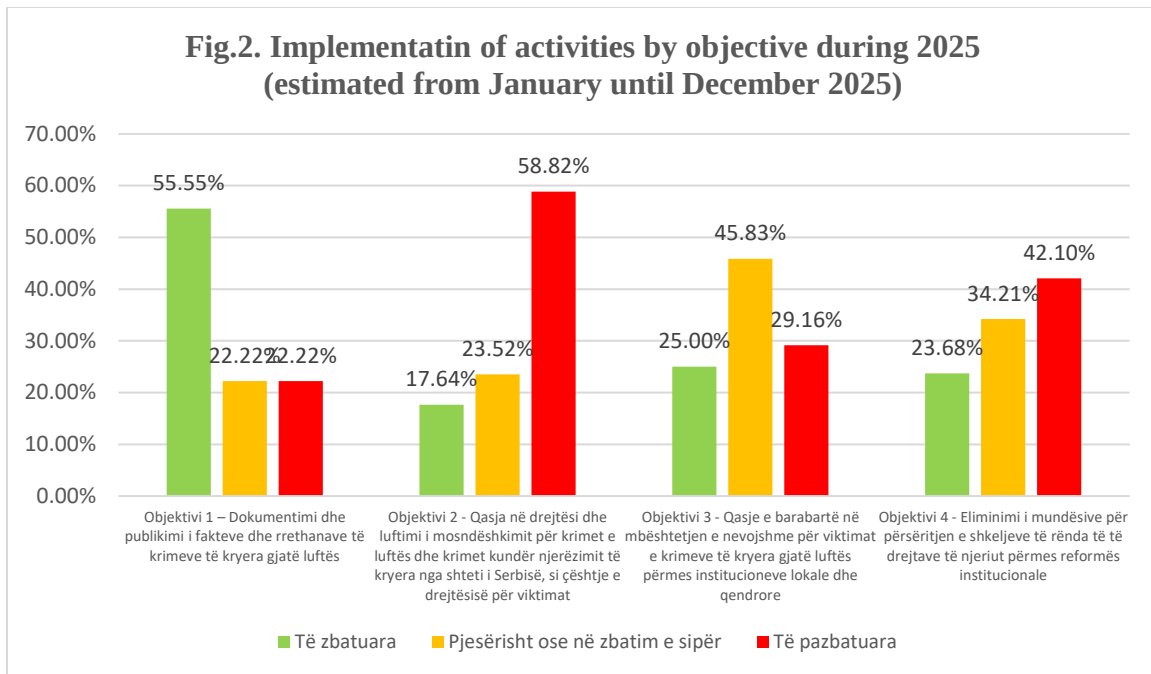

## Financial Sources

To implement the Action Plan and its activities, mainly Kosovo budget resources were used. Although reporting institutions have been requested to identify and report cases where activities have been financed by potential donors, no information has been received regarding such financing.

## Main implementation obstacles

Although this is the first strategy implementation year, a number of shortcomings affecting the implementation of the planned activities have been identified. These shortcomings are mainly related to budgetary constraints, insufficient planning, poor inter-institutional coordination, lack of human capacity, as well as lack of specific knowledge and consistency in implementation.

It is worth noting that the failure to implement activities, as well as delays or setbacks in their implementation, have a direct impact on the achievement of the Strategy's objectives, which are measured through defined indicators. In this regard, the overall performance in implementation also reflects the level of achievement of strategic results.

### **Any new factor impacting implementation**

During the monitoring period, new factors in addition to those mentioned above have been identified that have affected the full and planned implementation of the Action Plan. A key factor is the shift in priorities and the lack of continuity of focus on the planned activities.

It has also been noted that some institutions operate with overlapping mandates, which has caused the shift or distribution of individual responsibilities. Another factor is the non-inclusion of planned activities in legislative plans and in normative acts foreseen for amendment or supplementation.

Challenges also include the reduction or decrease of funds as a result of new global priorities, the disagreement between some of the donors with the content of the Strategy and the shift of funds destination by new priorities within the country. These factors have directly affected the delays and incomplete implementation of strategic activities.

### **Correcting measures suggested including provision of funds**

One of the main measures suggested is to ensure sustainable funding from the state budget, by reviewing and optimizing annual planning. At the same time, it is necessary to explore possibilities of coordination with partners and donors of international organizations, especially in the framework of integration processes.

Another necessary measure is capacity building, including especially between KIPA, as well as to organize specific trainings for research and policy creation, especially in certain areas such as public health.

In this regard, the concrete measures to be taken include:

- Ensuring a specific line and reviewing budget policies;
- Functionalization of the Inter-Ministerial Monitoring Group;
- Building specific capacities in responsible institutions;
- Identification and prioritization of key activities for implementation;
- Creation of a joint fund in agreement with donors.

These measures aim to guarantee more effective implementation of the Strategy and contribute to the achievement of its long-term objectives.

### III. ANALYSIS OF ACTIVITIES IMPLEMENTATION PROGRESS

The analysis of data for 2025 shows a moderate level of implementation of the Transitional Justice Strategy Action Plan, with notable differences between institutions and types of activities.

Of the total of 88 activities planned for this period, only 26% have been fully implemented, while 34% are under implementation. The high percentage of unimplemented activities (40%) points to structural challenges in the implementation of the Strategy, particularly in terms of coordination, planning and resources.

#### **Interpretation of implementation level**

The full implementation rate (26%) suggests that a significant portion of activities have not been completed in the planned period of time. However, the fact that 34% of activities are in the process of implementation is an indication that there is a certain level of institutional commitment, but with delays in implementation.

This combination of indicators highlights **a gap between planning and real implementation**, in which activities are initiated but not completed on time.

#### **Analysis by institutions**

The data show marked differences in institutional performance:

- Institutions with a clear mandate and specific functions (such as government commissions) have achieved higher rates of full implementation (up to 60–80%).
- Institutions with broader and cross-sectoral responsibilities (such as ministries) have shown lower levels of implementation and higher rates of unimplemented activities.
- Some institutions (e.g., in the fields of education and diplomacy) have very low levels of implementation (0–27%), reflecting a lack of prioritization or capacity.

This suggests that **clarity of mandate and institutional specialization are key factors for successful implementation**.

#### **Influence of activity nature**

Analysis indicates that:

- Activities requiring **inter-institutional coordination** have had more delays and lower levels of implementation.
- Activities that depend on **additional financial resources** are more often not implemented.
- Activities that are **technical and within the mandate of a single institution** have had better performance.

This suggests that the complexity of the activity directly affects the probability of its realization.

### Identifying main trends

Several trends emerge from the overall analysis:

- There is a tendency **for activities to be started without being completed within the deadlines;**
- There is a **high dependence on external factors**, such as funding and donors;
- There is a **lack of effective monitoring and accountability mechanisms.**

### Implications for implementation of Strategy

If the current trend continues, there is a risk that:

- strategic objectives will not be achieved in the foreseen deadlines;
- a gap will be created between strategic planning and real results;
- institutional credibility in the implementation of public policies will decrease.

For this reason, it is essential that in the next stages of implementation, concrete measures are taken to:

- strengthen inter-institutional coordination;
- increase professional capacities;
- improve planning and monitoring;
- secure sustainable financial resources.

## IV. CONCLUSIONS

The analysis of the implementation of the 2025 Action Plan shows that, although some progress has been achieved in the operationalization of the Transitional Justice Strategy, the

overall level of implementation remains below the expectations of the initial planning and requires immediate structural intervention.

The low rate of fully implemented activities (26%) and the high percentage of unimplemented activities (40%) testify to the existence of a significant gap between strategic planning and real implementation capacities. This gap reflects not only operational challenges, but also systemic limitations in inter-institutional coordination, resource management and policy prioritization.

The findings show that institutional performance is uneven, in which institutions with narrow mandates and clear responsibilities achieve significantly better results compared to institutions with broad and cross-sectoral mandates. This underlines the need for clarification of responsibilities and strengthening of accountability mechanisms.

One of the main challenges remains the lack of a functional and regular mechanism for inter-institutional coordination, also reflected in the complete dysfunctionality of the Inter-Ministerial Group during the reporting year. This has directly led to delays in implementation, especially for activities requiring cooperation between institutions.

Also, the lack of sustainable financial planning and integration of Strategy activities into budgetary and legislative frameworks has significantly limited the capacity for effective implementation. Dependence on uncertain funding sources and the lack of structured reporting on donor support pose a risk to the sustainability of the process.

In the operational terms, a tendency is seen to start activities without completion within the foreseen deadlines, which indicates weaknesses in planning, project management and progress monitoring. If remaining, this situation will negatively impact the achievement of strategic objectives and institutional credibility.

In this regard, to advance the implementation of the Strategy in the coming phases, it is necessary to:

- immediately strengthen the coordination and monitoring mechanisms, including the full operationalization of the Inter-Ministerial Group;
- fully integrate activities into budgetary and legislative planning;
- increase the professional and technical capacities of implementing institutions;
- establish clear accountability and reporting mechanisms;
- prioritize activities with high impact and greater feasibility.

In conclusion, the first year of implementation has served as an important initial phase for testing institutional mechanisms and identifying key challenges. However, to ensure the long-

term success of the Transitional Justice Strategy, a more structured, coordinated and financially supported approach is required in the coming years.

## **V. DETAILED INFORMATION ON ACTIVITY IMPLEMENTATION**
